2.0 <u>Draft Proposed Source Protection Plan</u>

Sommer Casgrain-Robertson reviewed the steps to be taken following Committee approval of the Draft Source Protection Plan.

- 1. The Draft Source Protection Plan would be posted on March 29, 2012 for a 35 day comment period.
- 2. Letters would be mailed to municipalities, implementers, affected property owners, and other interested parties.
- 3. Public open houses would be held on March 29 and April 19, 24, and 26.
- 4. A summary of comments received would be presented to the Committee for consideration in June.
- 5. Any necessary revisions would be made, and following Source Protection Authority review, a final 30 day comment period would commence. Any comments received at this stage in the process are submitted to the Ministry of the Environment for their consideration when reviewing the Plan.
- 6. The Proposed Source Protection Plan would be brought to both Source Protection Authorities, along with a summary of comments received, for submission to the Minister at a joint meeting on July 26, 2012.

Ms. Casgrain-Robertson then led the Committee through a page by page review of the Preliminary Draft Source Protection Plan and noted recommendations.

Ms, Casgrain-Robertson confirmed that the name of the document could and would be changed to "Draft Source Protection Plan", eliminating "Proposed" from the title.

Members were asked to review and, if necessary, submit revised biographies to staff for inclusion in the acknowledgement section of the Draft Source Protection Plan.
